LEADERSHIP EXPERIENCE

University of South Carolina, College of Arts and Sciences Dean, Feb. 2022 – Present; Interim Dean, Jan. 2021 – Feb. 2022

In this role, for the past four years, I have led the University of South Carolina's largest college in achieving its missions in teaching, research, creative achievement, and community engagement. The College of Arts and Sciences (CAS) has over 470 tenured and tenure-track faculty, 250 professional track faculty, 9500 undergraduate students, and 950 graduate students in a wide range of disciplines and more than 80,000 living alumni worldwide. CAS has 21 schools and departments, offers 48 Bachelor's degrees, 56 Master's degrees and 21 Doctoral degrees, covers 49% of all credit hours taught at the University of South Carolina and 94% of the Carolina Core (GenEd). In Academic Year 2024, CAS produced 98 PhDs.

Key Activities and Deliverables:

- Oversee an annual budget of more than \$450 million, which has grown in each of the past five years by increasing undergraduate student enrollment, federal research awards, and philanthropically endowed funds, while identifying targeted, mission-driven cost-savings opportunities all of which align with our core mission and vision.
- In partnership with other university offices, led the development and implementation of strategies that have increased freshman-to-sophomore retention rates from 87% to 92% across the College of Arts and Sciences.
- Oversaw an increase by over 70% in federal research grant dollars since 2021 while also increasing grant applications and grant awards by creating faculty incentives, building grant support structures, and expanding the team to assist all aspects of grant operations.
- Have grown faculty each year in leadership, including hiring 97 Tenure Track and Professional Track Faculty in 2021-22 Academic Year, the most by any college in a single year in the University's history, all with an 80% budget-neutral impact.
- Secured over \$100 million in philanthropic gifts in fiscal years 2022-25, each aimed at specific student experience and research missions of the College, including a \$75 million naming rights gift that will be announced in April 2025 for which I held the lead role for both cultivation and solicitation.

- In addition to the major naming rights gift, have partnered with development team to raise over \$7 million in FY 2024 and have raised over \$6 million per year each year as dean, increasing total funds raised each year.
- Led landscape analyses of College-wide issues, including unit teaching loads, staff and instructor salaries, and development accounts with an eye to making strategic, structural decisions.
- Comprehensively and strategically developed and implemented structural salary increases for both staff and instructors in the College for the first time in over a decade.
- Increased graduate student stipends across the College by as much as 25% in all units and provided health insurance for all graduate students (previously not covered).
- Inclusively developed and implemented first-ever College-wide Course Banking Policy, 3rd Year Review Leave Policy, Faculty Fellowship Policy, and Indirect Cost Return Policy, all focused on supporting faculty research.
- Developed College-wide research and teaching initiatives focused on (a) brain health (and neurodevelopmental disorders in particular), (b) disasters, hazards, and resilience, (c) school psychology, (d) social determinants of health; and (e) governance and democratic institutions.
- Oversaw creation and implementation of multiple new majors, including Cardiovascular Technology, Cyber Policy and Ethics, Data Analytics, Data Science, Neuroscience, and Industrial Design (in progress).
- In close collaboration with faculty, spearheaded the establishment of two new tenure-granting departments (African American Studies and Women's and Gender Studies) that had previously been non-tenure-granting academic programs, including securing unanimous BOT approval.
- Overhauled student advising structure in partnership with University Advising Center to professionalize advisement and regulate portfolio sizes by moving to four-year advisor model.
- Increased freshman enrollment by more than 16% while increasing credit hour production by nearly 20% and enrollment in 100-level courses by 24%.
- Partnered with unit-level faculty and cross-campus partners to develop strategies to reduce D/F/W rates in gateway courses, resulting in a reduction of more than 20% in number of gateway courses with high D/F/W rates over a two-year period.
- Created theme semester programs of courses, lectures, and activities across the full range of Arts and Sciences disciplines on various themes including justice, climates, and notions of play.
- Revised processes for engaging faculty in College governance and initiated faculty-led drafting of recently approved first-ever College By-Laws, which create increased and meaningful faculty governance in decisions that impact the College.
- Established first College-wide faculty budget committee in any college at the university.
- Transformed faculty development programs for both junior and mid-career faculty that have become models for the University as a whole.
- Developed unique, tailored program to support advanced associate professors on their path to full professor.
- Developed a leadership training program to develop a pipeline of leaders in the College.
- Reorganized several units in the Dean's Office, including budget office, communications, development, external relations, and grants office.
- Manage 44 buildings that make up the college's facilities infrastructure, including prioritizing over \$300 million in deferred maintenance and handling facility crises in multiple buildings.
- Oversaw 12 capital renovation projects to classroom and research facilities and performance spaces, totaling over \$105 million in capital improvements.
- Served as Co-Chair, University History Commission Implementation Group (charged with developing education, research, and building naming plans around the history of the African American experience as it relates to the University of South Carolina).

As Executive Director, I oversee an interdisciplinary center focused on supporting the rule of law around the world, with more than 60 faculty associates across 16 departments. Since I became Executive Director, ROLC has become one of the leading centers of its kind in the country and has increased programming by more than nine times, staff by eight times, and annual budget more than twenty-fold (from \$100,000 per year to over \$2 million per year). The Executive Director of the Rule of Law Collaborative (ROLC) reports directly to the Provost.

Key Activities and Deliverables:

- Led the development of novel tools to better understand and support efforts to build and sustain the rule of law both through developing capacity for local stakeholders and through building more skilled and thoughtful foreign development officers.
- Expanded understanding and awareness of mechanisms for the development of rule of law through people centered justice and forged new pathways for expanding programming focused on local conditions and needs.
- Played lead role in securing over \$26 million in grant funding over 10 years by identifying grant opportunities, leading grant writing efforts, and working with University officials to ensure compliance with complex procedures.
- Spearheaded efforts to build partnerships with public and private sector actors, leading to more than 20 new organizational relationships with a focus on developing joint projects and expanding scope of activities consistent with ROLC's mission and vision.
